CIRCULAR

As per provisions of Rule 37 of NDPS Rules 1985, manufacture of Narcotic Drugs require manufacturing license from Narcotics Commissioner.

Manufactured Narcotic Drugs are defined under Section 2 (xi) of the NDPS Act, 1985. Further, under Clause (b) of Sub-Section (xi) of Section 2 of NDPS Act, 1985, Manufactured Narcotic Drugs are declared vide Govt. of India's Notification S.O. 826(E) dated 14.11.1985, S.O. 40(E) dated 29.01.1993 & S.O. 1431(E) dated 21.06.2011.

According to these Notifications S.O. 826(E) dated 14.11.1985, S.O. 40(E) dated 29.01.1993 & S.O. 1431(E) dated 21.06.2011 preparations, admixtures, extracts or other substances containing any of these drugs also come under the definition of manufactured narcotic drugs. Therefore manufacturer of preparations, admixtures, extracts or other substances containing any of drugs mentioned under said Notifications S.O. 826(E) dated 14.11.1985, S.O. 40(E) dated 29.01.1993 & S.O. 1431(E) dated 21.06.2011 (except for the exemptions given in certain preparations of few narcotic drugs as mentioned in the abovementioned notifications) also require manufacturing license issued by Narcotics Commissioner under Rule 37 of NDPS Rules 1985.

Therefore all the manufacturers/formulators of various formulations of Manufactured Narcotic Drugs mentioned under Notification S.O. 826(E) dated 14.11.1985, S.O. 40(E) dated 29.01.1993 & S.O. 1431(E) dated 21.06.2011 require to apply in the prescribed format, annexed to this circular, to the office of the Narcotics Commissioner, Central Bureau of Narcotics, 19, the Mall Road, Morar, Gwalior-474006 and obtain manufacturing license under Rule 37 of NDPS Rules, 1985.
