As per the findings of DPC for the year 2022 for promotion of Lower Division Clerk to the grade of UDC held in the office of Narcotics Commissioner on 07-09-2021, Miss Richa Mishra, LDC hereby promoted to the grade of UDC (Group 'C') in Level-4 of pay matrix Rs. 25500/- {pre-revised scale PB-4 Rs.5200-20200+2400/- (Grade Pay)} with effect from the date they assume charge of the higher post, **not before 01-01-2022**.

- 1. The official should note that:
 - (a) If she does not accept the offer of promotion within 10 days from the date of issue of this order and fail to report for duty at her place, it will be considered as refusal of promotion and she will be debarred for promotion to the grade of UDC, for a period of one year.
 - (b) Seniority of Miss Richa Mishra in the grade of UDC will be reckoned on the basis of panel drawn by DPC for the year 2022.
 - (c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial up-gradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
- 2. The promotion, in the higher grade, in respect of the official shall take effect from the date they take over the charge of higher post, **not before 01-01-2022**.

- 3. Consequent upon promotion to the grade of UDC, Miss Richa Mishra is hereby posted in her present place of posting.
- 4. The above officer is directed to join the new assignment immediately, not before 01.01.2022.
