



Estt. Order No.96/2012

Shri Anil Kumar, Inspector of Central Bureau of Narcotics is hereby promoted to the grade of District Opium Officer / Superintendent (Ex.) (Group 'B'), in PB-2 Rs. 9300-34800 + 4800 (Grade Pay) as per the findings of DPC 2012-2013 held on 28.8.2012, with effect from the date he assumes charge of the higher post.

1. The above official should note that:

(a) This promotion order is subject to the outcome of the decision by the Hon'ble High Court of Delhi in the writ Petition (C) No.14763/2006, Writ Petition No.21803/2006 in the High Court, Allahabad, O A No.56/2006 in CAT Jaipur and OA No.232/2004 in CAT Allahabad.

(b) If he does not accept the offer of Promotion within 10 days of issue of this order and fail to report for duty at their respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of District Opium Officer / Superintendent (Ex.), for a period of one year.

(c) Seniority of Shri Anil Kumar, Inspector in the grade of District Opium Officer/Superintendent (Ex.) shall be reckoned on the basis of the panel drawn by the DPC 2012-13.

(d) He is required to submit within one month of promotion, his option of fixation of pay on promotion under O.M. No. 7/1/80-Estt.I, dated 26.9.81. However, where the official has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.


2. The above official should also note that the above promotion is subject to the condition of successful completion of probation period of two years which can be extended, if his performance during the period of probation is not found to be satisfactory. The above officer is also required to pass the departmental examination in terms of Departmental Examination (Central Excise and Customs) Rules, 2008, as amended.

3. The promotion, in the higher grade, in respect of above official shall take effect from the date he takes over the charge of higher post at his respective place.

4. Consequent upon the above promotion, the following transfer & posting in the grade of Supdt./D.O.O. is hereby ordered with immediate effect:-
