ORDER No. 104/2012

The Govt. of India, Ministry of Personnel, Public Grievances and Pensions O.M. No.35034/3/2008-Estt (D) dated 19th May, 2009 introduced the Modified Assured Career Progression (MACP) Scheme for the Central Government Civilian Employees who have completed 10, 20 or 30 years of regular service without any promotion from the direct entry grade or wherever a person has spent 10 years continuously in the same grade pay. The MACP Scheme has come into force w.e.f. 01.09.2008. Accordingly, the cases of the following Group 'B' and 'C' officials matured up to 30.09.2011 were considered by the Departmental Screening Committee meeting held on 26.07.2012 at Hqrs. office and found them 'Fit' for grant of 1st, 2nd and 3rd financial upgradation, as the case may be, under MACP Scheme with effect from the dates shown against each in their respective higher grade pays. The findings of the Screening Committee in respect of the officials, against whom disciplinary proceedings etc. are pending on the due date i.e. eligibility of the officers, have been kept in sealed Covers:-

The above officials should keep in mind that this financial upgradation is granted subject to the conditions as laid down in para 1 to 28 Annexure-I appended with DoPT's above O.M. dated 19.05.2009. After acceptance of the financial upgradation under MACP Scheme, no pay benefit will be granted to them again on their regular promotion except the difference of grade pay in their hierarchy in the next higher grade. No additional increment will be granted on their regular promotion. They are also directed to submit their option whether they are ready to accept this 1st, 2nd and 3rd financial upgradation under MACP Scheme or otherwise, to their controlling officer. Option so exercised shall be final.
