

**MINUTES OF THE PROCEEDINGS OF 'DRAW OF LOTS' HELD ON 06/02/2019 AT CBN, HEADQUARTERS OFFICE FOR DRAWING THE PRIORITY LIST OF APPLICATIONS RECEIVED IN PURSUANCE TO THE PUBLIC NOTICE NO. PS-1/2019 DATED 08.01.2019 FOR REGISTRATION OF SALES CONTRACT FOR IMPORT OF POPPY SEEDS FROM CZECH REPUBLIC**

In pursuance of Public Notice No. PS-1/2019 dated 08.01.2019, the proceedings of 'Draw of Lots' was held at 11.00 hours in the CBN Headquarter, Gwalior for drawing the priority list of applications received for registration of sales contract for import of poppy seeds from Czech Republic.

The proceeding was headed by Shri Ajoy Kumar, Asstt. Narcotics Commissioner in the presence of Shri Arvind Saxena, Superintendent and Siddharth Srivastava, Inspector.

The proceedings started by welcoming the representative present from the trade who have applied for registration of sales contract for import of Poppy Seeds from Czech Republic. 13 representatives from the applicant firms were present during the proceeding (list attached).

At the onset Shri Ajoy Kumar explained the procedure to be adopted in the proceeding to the representatives from the firms and they gave their consent to go ahead with the same. Computerized slips indicating serial numbers were prepared. Opportunity was given to each participant to come and verify the serial number on slips and put it in the bucket. In response to this, 2 participants namely: 1) DHARAM MOMAYA, Dhirish International, 2) RISHI JAITHLIA, Seasons International Pvt Ltd, volunteered to verify the Sl. Number printed on the slip and put in the bucket. Dharam Momaya read out the sl. Number printed in the slip whereas Rishi Jaithlia cross checked with the final list uploaded on the CBN official website on 04.02.2019. After verification, each slip was folded and dropped in the bucket by the person reading out the sl. Number on the slip. After all the slips were placed in the bucket and participants were again asked to come up and mix slip in the bucket. Amit Bhatia voluntarily mix slips in the bucket. After this, opportunity was given to participants to take out slips one by one.

First 20 slips were taken out by Mohd Aslam and cross checked by Dharam Momaya, then next 20 slips were taken out by Sithik Rahman and cross checked by R Arunachalam then next 20 slips were taken out by Amit Bhatia and cross checked by Harish Goyal, then next 20 slips were taken out by Akhil Agrawal and cross checked by Anil Soni, and then next 20 slips were taken out by Vivek Bansal and cross checked by K B Singh. This process was continued till the priority list of 100 applicants was made. This Priority List was prepared only till 100 applicants keeping in view that number of registration to be granted would be in the range of 10 to 15 applicants. Keeping the list restricted to 100 applicants was agreed by the representative of the applicant firms present.

Once 100 slips were taken out by participants, a page containing serial number of slip picked up in their order of picking up was signed by a few participants present.

The entire process was completed in a cordial manner. Priority list prepared by draw of lot is
