PUBLIC NOTICE No.PS- 11 /2016

Narcotics Commissioner invites application from interested parties for registration of sales contract for import of Poppy seeds from China.

**Category –I :** Applicants who had applied in response to this office Public Notice No. PS-1/2016 dated 27.11.2016 and whose sales contracts are not expiring before 31<sup>st</sup> January, 2017.

These applicants may submit confirmation of their request in Format-I in response to Public Notice No. PS-1/2016 on or before 15<sup>th</sup> November, 2016 either by way of e-mail/post.

**Category-II :** Applicants who had applied in response to Public Notice No. PS-1/2016 and sales contracts submitted by them are expiring before 31<sup>st</sup> January, 2017.

All such applicants are required to submit application in Format II either by way of e-mail/post on or before 15<sup>th</sup> November, 2016 In this case fresh sales contracts/renewed sales contract (validity extension letter) is also required to be submitted.

**Category-III:** those applicants who had not applied in response to Public Notice No. PS-1/2016

These applicants are required to make application in Form-III along with Demand Draft for Rs. 1000/- .

**Category IV** : Applicants who had applied in response to this office Public Notice No. PS-1/2016 dated 27. 1.2016 but wish to submit additional sales contract (in addition to sales contract in Category I & II) should make an application in Format-III along with DD for Rs. 1000/- and other documents as mentioned in Format-III

**Note:**

- (1) All applicants are required to send their application either by way of e-mail/post on or before 15<sup>th</sup> November, 2016
- (2) For the purpose of cutoff date, the date of receipt of application along with requisite documents and DD (wherever applicable) will be Date of receipt of e-mail at [suptd-narco@cbn.nic.in](mailto:suptd-narco@cbn.nic.in) or by post whichever is earlier. However, application will be processed only after receipt of hard copy of application and other requisite documents.
- (3) The validity of registration of sales contract shall be up to 31<sup>st</sup> January, 2017.
- (4) The above procedure of registration will be valid only if the total quantity mentioned in the sales contract submitted by all eligible applicants taken together does not exceed the country cap.
- (5) Registration of contracts for Category I & II applicants above shall be completed before consideration of new applicants under Category III and IV.
