PUBLIC NOTICE NO. PS-2/2017 - PROCEDURE FOR CONDUCTING 'DRAW OF LOTS' TO BE HELD ON 27/04/2017 AT CBN HEADQUARTERS OFFICE FOR DRAWING THE PRIORITY LIST OF APPLICATIONS RECEIVED FOR REGISTRATION OF SALES CONTRACT FOR IMPORT OF POPPY SEEDS FROM TURKEY.

Reference invited to Public Notice No. PS-1/2017 dated 21st April, 2017 informing that CBN proposes to conduct draw of lots for preparing priority list for selection of applicants for the purpose of registration of sales contract for import of Poppy Seeds from Turkey. The procedure for the same will be as under:-

- 1) Initially, the list of applicants who have applied for registration of sales contract for import of poppy seeds from Turkey will be displayed at the Notice Board. (can also be viewed at in the departmental website of CBN at <http://cbn.nic.in> in Public Notice No. PS-16/2016 dated 23rd December, 2016)
- 2) Applicants/ their representative can ascertain their serial from the list displayed at the Notice Board/ departmental website of CBN at <http://cbn.nic.in>
- 3) The 'Draw of Lots' will be held at the Conference Hall of CBN Headquarters, Gwalior at 12:00 hrs on 27th April 2017, before the applicants/ their representatives who are present to witness the proceeding of 'Draw of Lots'.
- 4) The 'Draw of Lots' will be conducted using computerized system for generating randomized list of applicants. The priority list will be generated in the following manner.
 - (A) The computer programme which will be used for generating priority list of applicants will throw up/ prepare different priority list on pressing key F9 in the keyboard. In other words, each pressing of key F9 would generate different priority list. This can be verified by few applicants/ their representatives who are present for witnessing the 'Draw of Lots'.
 - (B) Trial priority lists generated in Step (A) above for a few instances can be verified/ pursued by the applicants/ their representatives on the computer terminal itself.
 - (C) In order to determine the number of times key F9 is to be pressed to generate effective/ final priority list, manual draw shall be carried out in the manner below: –

- (i) One box will be kept having slips bearing numbers from 0 to 10. One representative will be requested to pick the slip from the box. For example, if slip picked up bears the number '4', then key F9 will be pressed 4 times to generate the priority list. In case, more than one representative is willing to pick up the slip, then the chance to pick the slip will be given to the applicants/ their representatives selected through manual draw of lots of all desirous applicants/ their representatives.
 - (ii) Representative (*other than who have picked up the slip at Step (i) above*) will be requested to press key F9 in the keyboard, the number of times as ascertained in Step (i). In case, more than one representative is willing to press the key F9, then the chance to press the key F9 will be given to the applicants/ their representatives selected through manual draw of lots of all desirous applicants/ their representatives.
- (D) Final/ effective priority list generated will be printed and the same will be signed by minimum three applicants/ their representatives in each page of priority list. This priority list so signed will be scanned and uploaded in the departmental website of CBN at <http://cbn.nic.in> as early as possible.
- (5) Any applicant/their representative may witness and video graph the proceedings of draw of lots, if so desires`
