1. Applications for registration of contract for import of poppy seeds from China & Czech Republic can be submitted by post only. Application received by hand will not be entertained. The last date for receipt of application is 31<sup>st</sup> July, 2015. Application received after last date shall not be entered at any cost.

2. Only One Application per applicant shall be accepted.
3. An application shall be accepted only if requisite documents are found to be proper and complete in all respect, and same will be acknowledged with date and Seriatim number. Incomplete application or application without all requisite documents will be summarily rejected and returned to the applicant along with Deficiency Memo.
4. For registration of contract of import of poppy seeds from China & Czech Republic, the Ministry's existing guidelines F. No. N-22012/3/2013-NC-I dated 8<sup>th</sup> July, 2014 would be followed.
5. The Envelope containing application should be superscripted with "Application for import of poppy seed from \_\_\_\_\_ (name of Country)".
