

Those officials who are transferred on the basis of request will not be granted T.A/D.A.

This disposes off all the representations for transfer in the grade of Inspectors. No further representation will be entertained without joining new place of postings.

The Dy.Narcotics Commissioner of each unit will further decide place of posting of the transferred officials except those who are transferred on the basis of request. The history of postings of the officials may be given due consideration and postings may be given strictly according to the norms provided in the AGT Policy. It may be ensured that a balance in working strength is maintained between DOO office and P& I Cells. 
