**Online system for registration and submission of returns/  
reports by the Manufacturers & Wholesalers of Psychotropic  
Substances**

**NOTICE**

As you are aware that the government of India has launched a web-enabled system of "Online Registration and submission of online returns by the Manufacturers & Wholesalers of Psychotropic Substances". This system is being implemented to facilitate registration of manufacturers and wholesalers of psychotropic substances (bulk as well as preparations) in the country to get registered, to submit online import/ export applications and quarterly returns/ reports of psychotropic substances they are dealing with, such as domestic sales, purchase, export/ import, usage, R&D activities. This portal can be accessed through url <https://cbnonline.gov.in>.

As on date about 140 companies mainly manufacturers/ exporter have already submitted the requests for online registration. The ministry has now initiated the process to amend the NDPS Rules, 1985 to incorporate enabling mandatory provisions for online registration and submission of online returns by manufactures and wholesalers of psychotropic substance.

In this context, the Ministry has advised this office to organize workshops in major cities, viz., Delhi, Mumbai, Bangalore and Ahmedabad where both manufactures & wholesalers of psychotropic substances and pharmaceuticals associations are invited to evaluate their reaction on this matter as detailed below -
