



PUBLIC NOTICE No.PS-7/2015

As per Ministry's guidelines issued vide F.No.-N-22012/06/2015-NC-I dated 08th September, 2015 for registration of sale contracts for import of poppy seeds in India from Turkey, 50% of the estimated production of poppy seed from fresh harvest and carried over stock from last crop year as conveyed by the Competent Turkish Authorities is to be reckoned to arrive at the provisional country cap from Turkey. Turkish Embassy, Office of the Commercial Counsellor, New Delhi vide their letter Ref. 87514139/100 dated 7th July, 2015, has informed that quantity of 29750 MT (approx) white poppy seeds is likely to be available in 2015 in Turkey. Accordingly, the provisional country cap for Turkey for FY 2015-16 in respect of white poppy seeds has been determined at 14875 MT i.e. 50% of 29750 MT.

Provisional country cap will be apportioned between the applicant in the following manner :

- (a) Applicant who have imported poppy seeds from Turkey to India for at least 3 Financial Years during the last 5 Financial years shall be categorized as Category 'A'. This category of importers shall be allotted a quantity from the provisional country cap which is the average ratio of the import by 'Category 'A' and Category 'B' of importers in last 5 Financial years.

- (b) Other importers shall be categorized under Category-B and shall be allotted the balance amount of provisional quota after allocation is done as per (a) above.

Accordingly fresh applications are hereby invited from desirous applicants for registration of sales contract for import of poppy seeds from Turkey into India for the year 2015-16.

Any company/applicant desirous to import poppy seed shall apply in the prescribed proforma to Narcotics Commissioner to register their sales contracts prior to import with the Narcotics Commissioner, Gwalior and submit following documents in support of their request for registration of sales contract for import of poppy seed,

1. Application & Background information (Attached with this notice.) The application & background information is required to be signed by the proprietor/any of the partners. In case of company, the application should be signed by any of the Executive Director or authorized person duly empowered by Board of Directors. (In such a case, Board Resolution in original/certified copy is to be submitted).
2. Sales contract in original duly signed by the importer as well by the exporter. Applicants who have already submitted sales contract in original to Central Bureau of Narcotics alongwith application furnished in pursuance to Public Notice No. PS-4/2015 dated 10.8.15 are not required to submit the sales contract in original again. They have to mention the Sales Contract No. & Date in the relevant column of the application.
3. Attested copy of PAN card

4. Attested copy of Import Export Code(IEC) issued by DGFT
5. Demand Draft worth of Rs 560/- in favour of Drawing and Disbursing Officer, Central Bureau of Narcotic.
6. Address of Jurisdictional Commissionerate of Central Excise under which firm lies. In case registered with Central Excise, the copy of Central Excise Registration Certificate

Applicants also please note that :

(1) Applications for registration of contract for import of white poppy seeds from Turkey shall be submitted by post/courier only . No Application sent by hand will be accepted by this office

(2) Application will be accepted, received between 9.30 AM of 23.9.15 to 6.00 PM of 5.10.15. Any application received after the specified date will not be accepted at any cost and will be returned to the applicant and will not be taken on record. The Envelope containing application should be superscribed "Application for import of poppy seed from Turkey " under Category "A" or Category "B" as the case may be.

(3) Applicants in Category-A shall be allowed to register sales contracts for the quantity applied for, or two hundred and seventy MT (270 MT) whichever is less whereas an applicant in Category-B shall be allowed to register sales contracts for the quantity applied for, or one hundred and Eighty MT (180 MT) whichever is less. However, it is clarified that Registration of sales contract for import of poppy seeds will be issued only for import to the extent of provisional country cap fixed for the FY 2015-16. If the

quantity available for allocation to the applicants is insufficient to allocate to all the applicants , selection of application shall be done through 'draw of lots'. Categorywise Importer 'priority list 'shall be made which shall be in accordance with the 'draw of lots'. Quantity available for allocation to applicants shall be allocated as per the priority list prepared through 'draw of lots' till the available quantity is exhausted. The draw of lots will be made at 11.00 AM of 8th October, 2015 in the Office of Narcotics Commissioner, Gwalior and interested applicants may remain present themselves during the proceeding of drawing of lots. If draw of lots is not required for any particular category, the same will be informed by way of Public Notice on 7th October, 2015. Those applicants who do not receive any allocation due to exhaust of the provisional country cap shall put on 'waitlist' for consideration against final country cap after it is determined. No fresh application will be invited for registration of sales contract against final country cap.

(4) Each importer with a specific Importer-Exporter Code (IEC) shall submit only one (1) application and shall clearly indicate in his application the total quantity of poppy seeds sales contract they wish to register. In cases where more than one application are submitted by any importer with a specific Importer-Exporter Code (IEC) all such application shall be rejected.

(5) An application shall be accepted only if requisite documents are found to be proper and complete in all respect. Incomplete application or application without all requisite documents will be summarily rejected and returned to the applicant along with Deficiency Memo and shall not be taken on record..

(6) For registration of contract of import of white poppy seeds from Turkey the Ministry's guidelines issued under F.No. N-22012/06/2015-NC-I dated 8th September, 2015 would be followed which is placed on the official website of Central Bureau of Narcotics.

(7) The import contracts which will be registered by the Narcotics Commissioner against the provisional country cap shall be valid for a period of 4 months only from the date of issue, however imports which are registered after the final country cap shall be valid upto 30th June of the next year (which shall not be extended in any case).

(8) An applicant, after registration of sales contract may surrender part or full of registered quantity by communicating in writing and received by the Narcotics Commissioner within a period of 30 days from such registration.

(9) (i) Country of Origin Certificate will have to be produced before Custom Authority at the time of import.

(ii) An applicant shall submit details of each import of white poppy seeds alongwith photo copy of Country of Origin Certificate within 15 days of import to the Narcotics Commissioner.

(10) If an importer fails to import a minimum of 50% of the quantity registered for import, less the quantity surrendered, he shall be debarred from registration of sales contract for a period of two years.

(11) Attention is invited to Para 2(v) of Ministry's of Finance, Department of Revenue's letter F.No. N-22012/3/2013-NC-I dated 26th December, 2014 where under the provision of debarment in future were notified. Accordingly, the said condition would apply in respect of importer whose sales

contracts were registered on or after 26.12.14. Therefore, the applicants who have violated condition of minimum 50% of import of registered quantity shall not be eligible for registration of sales contract in response to this Public Notice.

(12) If at any stage, it is found that information/documents submitted by any applicant are false, misleading or fictitious, then, not only his sales registration will liable to be revoked but he may proceeded against for action in terms of provision of any law for time being in force.
