

MINUTES OF THE PROCEEDINGS OF 'DRAW OF LOTS' HELD ON 24/07/2017 AT CBN, HEADQUARTERS OFFICE FOR DRAWING THE PRIORITY LIST OF APPLICATION RECEIVED IN PURSUANCE TO THE PUBLIC NOTICE NO. PS-8/2017 DATED 22.06.2017 FOR REGISTRATION OF SALES CONTRACT FOR IMPORT OF POPPY SEEDS FROM CZECH REPUBLIC

In pursuance of Public Notice No. PS-8/2017 dated 22.06.2017, the proceedings of 'Draw of Lots' was held at 11.00 hours in the CBN Headquarter, Gwalior for drawing the priority list of of applications received for registration of sales contract for import of poppy seeds from Czech Republic.

The proceeding was headed by Shr Dharam Raj, Asstt. Narcotics Commissioner in the presence of Shri Priya Ranjan, Superintendent and Arvind Saxena, Inspector.

The proceedings started by welcoming the representative present from the trade who have applied for registration of sales contract for import of Poppy Seeds from Czech Republic. Four representatives from the appliant firms were present during the proceeding (list attached).

At the onset Shri Priya Ranjan, Superintendent explained the procedure to be adopted in the proceeding to the representatives from the firm and they have consented to go ahead with the same.

Computerized slips indicating serial numbers and name of the applicants were prepared. Opportunity was given to each participant to come and verify the serial number on slips and put it in the bucket.

In response to this two participants namely S/Shri Sharan Soni of Soni Enterprises and Mohd. Aslam of Naaz International Trading Co. voluntared to verify the Sl. Number and Name printed on the slip and put it in the bucket. Shri Sharan Soni read out the name and sl. Number printed in the slip where Shri Mohd. Islam cross checked with the list uploaded on the CBN official website on 22nd June, 2017. After verification, each slip was folded and drop in the bucket by the person reading out the sl. Number and name on the slip. After all the slip were placed in the bucket and participants were again asked to come up and mix slip in the bucket. Shri Mohd. Islam voluntarily mix slip in the bucket. After this, opportunity was given to participants to take out fifteen slips one by one. First fifteen slips were taken out by Shri Laxman Singh of Regency Spices, then next fifteen slips were taken out by Shri Dharam Momaya of Dharam International, then next fifteen slips were taken out by Shri Sharan Soni and remaining nine slips were taken out by Shri Mohd. Aslam and priority list was prepared accordingly. This process was repeated till the priority list of 54 applicants was made. Once all 54 slips were taken out by participants, a page containing serial number of slip picked up in their order of picking up was got signed by all participants present


The entire process was completed in a cordial manner. Priority list prepared by draw of lot is annexed.
