**Notice of termination of service issued under Rule 5(1) of the Central Civil Services
(Temporary Service) Rules, 1965**

Whereas, it has been brought to notice of the undersigned that discrepancy has been observed while scrutiny of dossier of Shri Md Zakir Hussain, Hawaladar, CBN by this office (Roll no : 7204700178) pertaining to Multi Tasking(Non-Technical) Staff, and Havaladar (CBIC & CBN) Examination 2021. It has been observed that photo of Md Zakir Hussain, Havaladar on Admission Certificate is different from photo captured at various stages of examination.

Whereas this office on enquiry with respect to thumb print of person appearing during various stages of examination with specimen (thumb print) of Md Zakir Hussain, Havaladar, CBN from the Office of Director, Finger Print Bureau, Jaipur, Rajasthan revealed that they are dissimilar and unidentical.

Further, it is stated that thumb prints are widely accepted as a reliable and consistent biometric identifier, and such a discrepancy introduces significant dissimilarity regarding the authenticity of the identity claimed during recruitment and at the time of appointment/joining.

Whereas, after thorough examination of documents available on records it is found that thumb print on admission certificate of person who appeared for Multi Tasking(Non-Technical) Staff, and Havaladar(CBIC & CBN) Exam 2021 which was taken in presence of Invigilator, other thumb prints taken during examination process are dissimilar and unidentical from specimen left and right thumb prints of Md Zakir Hussain, Havaladar CBN. Therefore, it can be concluded that person who has appeared in Multi Tasking(Non-Technical) Staff, and Havaladar(CBIC & CBN) Exam 2021 is different from the one who has joined the department.

Therefore, in pursuance of proviso to sub-rule (1) of Rule 5 of the Central Civil Services (Temp Service) Rules, 1965, I, Naresh Bundel, Deputy Narcotics Commissioner, Central Bureau of Narcotics, Kota hereby terminate forthwith the services of Shri Md. Zakir Hussain, Havaladar and direct that he shall be paid a sum equivalent to the amount of his pay and allowances for the period by which the said notice short of one month calculated at the same rates at which he was drawing them immediately before the date of this order.
