

Establishment Order No 03/2025

As per the findings of the DPC for the year 2025 for promotion from the post of Inspector to the post of Superintendent/DOO held in the office of Narcotics Commissioner, Gwalior on 10.01.2025, the following Inspectors are hereby promoted to the post of Superintendent/DOO (Group 'B' Gazetted) in Level-8 of pay matrix Rs. 47,600 to 1,51,100 on in-situ basis with effect from the date they assume charge of the higher post.

1. The above officials should note that:


(a) If an officer does not accept the offer of promotion within 10 days of issuance of order and fail to report for duty at his respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Superintendent/DOO, for a period of one year.

(b) Their seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2025.

(c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt. (Pay-I) dated 27th July 2017. However, where the official has been granted benefit of financial upgradation under the ACP/MACP Scheme, his pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034 1/97-Estt. (D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

3. Promotion of the above officials will be subject to outcome of "OA No. 1297/2024 R. K. Choudhary Vs Revenue" filed before Hon'ble CAT bench at Jabalpur and "O.A. No. 2651/2024 H. K. Dhanwani and ors. Vs Union of India & ors." filed before filed before Hon'ble CAT, PB, New Delhi.
