## Estt. Order No.17/2025

As per the findings of DPC for the year 2024 for promotion of Upper Division Clerk to the grade of Deputy Office Superintendent (DOS) held in the office of Narcotics Commissioner on 26.12.2024, the following Upper Division Clerk is hereby promoted to the grade of Deputy Office Superintendent in Level-6 of pay matrix Rs. 35,400 to 1, 12,400/- with effect from 26.12.2024

- 1. The official should note that:
- (a) If he does not accept the offer of promotion within 10 days of issue of order and fail to report for duty at his place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Lower Division Clerk, for a period of one year.
- (b) His seniority will be reckoned on the basis of panel drawn by DPC for the year 2025.
- (c) He is required to submit within one month of promotion, his option of fixation of pay on promotion as per DoPT's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
- 2. The promotion, in the higher grade, in respect of the officials shall take effect from 01.01.2025 after they take over the charge of higher post.
- 3. Consequent upon promotion to the grade of Deputy Office Superintendent, the following official is hereby posted in the office as mentioned below:
