Estt. Order No. 19/2024

As per findings of the DPC year 2023, for promotion in the grade of Superintendent/DOO from the post of Inspector held in the office of Narcotics Commissioner on 16.04.2023 and DPC year 2024 held in the office of Narcotics Commissioner on 15.01.2024, the following Inspector is hereby promoted to the post of Superintendent/DOO (Group 'B' Gazetted) in Level-8 of pay matrix Rs. 47,600 to 1, 51,100 with effect from 01.07.2024 or the date they assume charge of the higher post.

1. The official should note that:

(a) If he does not accept the offer of promotion within 10 days of issue of order and fail to report for duty at his respective place, it will be considered as refusal of promotion and he shall be debarred for promotion to the grade of Superintendent/DOO, for a period of one year.

(b) His seniority will be reckoned on the basis of panel drawn by the above mentioned DPC for year 2023.

(c) He is required to submit within one month of promotion, his option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.

2. The promotion, in the higher grade, in respect of the official shall take effect from the date he takes over the charge of higher post.

3. His regular posting will be decided in due course. Till then he shall assume the charge of the promotional post on in situ (as is where is) basis.

4. The above officer may join the new assignment immediately. A compliance report on the same should be sent to the undersigned immediately.


