As per the findings of DPC for the year 2024 for promotion of Multi-Tasking Staff to the grade of Lower Division Clerk held in the office of Narcotics Commissioner on 26.12.2024, the following Multi-Tasking Staff are hereby promoted to the grade of Lower Division Clerk in Level-2 of pay matrix Rs. 19,900-63,200/-with effect from 01.01.2025 after they take over the charge of higher post.

1. The officials should note that:

- (a) If they do not accept the offer of promotion within 10 days of issue of order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of Lower Division Clerk, for a period of one year.
- (b) Their seniority will be reckoned on the basis of panel drawn by DPC for the year 2025.
- (c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No.13/02/2017-Estt.(Pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial upgradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 9.8.1999 and for MACP, provisions contained in DoPT's O.M.No.35034/3/2008-Estt.(D) dated 19.5.2009 respectively.
- 2. The promotion, in the higher grade, in respect of the officials shall take effect from 01.01.2025 after they take over the charge of higher post.

- If the above officers accept the promotion in the grade of Lower Division Clerk, as 6. per G.S.R. 773(E) dated 18.12.2024, they are required to pass the Departmental Examination within 2 years of promotion.
- The above officers should be relieved and directed to join the new assignment immediately. A compliance report on the same should be sent to the undersigned immediately.
