1. The above officials should note that:

(a) If they do not accept the offer of promotion within 10 days of issue of this order and fail to report for duty at their respective place, it will be considered as refusal of promotion and they shall be debarred for promotion to the grade of AO/ACAO, for a period of one year.

(b) Their seniority will be reckoned on the basis of panel drawn by DPC for Panel Years 2019-19.

(c) They are required to submit within one month of promotion, their option of fixation of pay on promotion as per DoP&T's O.M.No. 13/02/2017-Estt.(pay-I) dated 27th July 2017. However, where the officials have been granted benefit of financial up-gradation under the ACP/MACP Scheme, their pay would be fixed in accordance with the provision contained in Para 9 of Annexure to DoPT's O.M. No.35034/1/97-Estt.(D) dated 09.08.1999 and for MACP, provisions contained in DoPT's O.M.no.35034/3/2008-Estt.(D) dated 19.05.2009 respectively.

2. The promotion, in the higher grade, in respect of above officials shall take effect from the date they take over the charge of higher post.




