**Note:-**

1. The Dy. Narcotics Commissioner of each unit will further decide place of posting of the officers who have transferred to the field units. The history of postings of the officials may be given due consideration and postings may be given strictly according to the norms provided in the AGT Policy. Further, the rotation of officers who have completed 2yrs or more in a particular charge or have completed their tenure at a station should be rotated subject to tenure mentioned in the AGT guidelines.
2. The posting station of officer transferred to CCF organization will be further decided by the CCF, New Delhi.
3. Transfer of Officers at Sl. No. 26, 52, 53, 54 & 60 has been made on their own request and will not eligible for TTA
4. The above officers should be relieved by immediately. Before relieving they shall properly hand over the charge/documents/equipment/items etc. A compliance report of relieving/ joining should be sent to the undersigned.
5. This disposes off all the representations in various grades for AGT-2022. No further representation will be entertained without joining at new station.
