Subject: Changes to streamline the system of sending estimates and reports to the INCB and allocation of quota to the companies-regarding.

Reference is invited to this office letter F.No.19/2/Tech/2009 pt dated 26th - 30th March, 2010 informing the trade that the procedure of allocation of quota of narcotic drugs has been changed from this year vide Office Memorandum issued by Department of Revenue, Ministry of Finance, Government of India vide F.No. N12019/10/2009-NC-II dated 9th March, 2010.

- In terms of the above mentioned Office Memorandum, the Narcotics Commissioner, Central Bureau of Narcotics, Gwalior has to allocate the quota of narcotic drugs to all the consuming companies for the year 2010, hitherto being done by the Drug Controller of respective States.
- As has already been mentioned, it has been observed from certain cases 3. which have come to us that the State Drug Controllers have extended the validity of 2009 quota upto 31st March 2010. It is to reiterate that the quantity procured and consumed during 1st January, 2010 to 31st December, 2010 only would be counted against estimate for the Calendar year 2010, as the annual statistics has to be reported to the International Narcotics Control Board (INCB), Vienna on Calendar year basis.
- Thus, the quantity of quota extended beyond 31st December, 2009 will be counted as allocation for the year 2010. The details of such extension of previous year quota/ allocation made by the State Drug Controllers during current year has to be reported to this office while submitting application for grant of more quota.

Ouota allotement-2010

- 4. Further, this office has requested the consuming companies / formulators of narcotic drugs vide letter of even no. dated 26<sup>th</sup> 30<sup>th</sup> March, 2010 (copy enclosed) to furnish **the details of quantity of narcotic drugs procured, consumed and sold from 1**<sup>st</sup> **January, 2009 to 31**<sup>st</sup> **December, 2009** in prescribed proforma (copy enclosed), so that this department may start preparation of Form 'C' (consumption report of 2009) for onward transmission to INCB. So far, this office has not received any response in this regard from manufacturers / formulators of narcotic drugs.
- 5. It is, therefore, advised that the information sought vide this office letter of even no. dated 26<sup>th</sup> 30<sup>th</sup> March, 2010 be submitted to this office by post and e-mail before 15<sup>th</sup> April, 2010. It may please be noted that the application(s) for grant of quota of narcotic drugs would not be considered by this office in respect of companies who have failed to furnish the consumption details for 2009.
- 6. This may please be treated as most urgent.

## Subject: Changes to streamline the system of sending estimates and reports to the INCB and allocation of quota to the companies-regarding.

As you may be aware that the procedure of allocation of quota of narcotic drugs has been changed from this year vide Office Memorandum issued by Department of Revenue, Ministry of Finance, Government of India vide F.No. N12019/10/2009-NC-II dated 9th March, 2010.

- 2. In terms of the above mentioned office memorandum, the Narcotics Commissioner, Central Bureau of Narcotics, Gwalior has to allocate the quota of narcotic drugs to all the consuming companies for the year 2010, hitherto being done by the Drug Controller of respective States.
- 3. As per the above OM dated 9.3.2010, no further allocation of quota of narcotic drugs to the companies should be made by the State Drug Controller.
- 6. It is requested to furnish the details of quantity of narcotic drugs procured, consumed and sold from 1<sup>st</sup> January, 2009 to 31<sup>st</sup> December, 2009 in the enclosed proforma, so that this department may start preparation of Form 'C' (consumption report of 2009) for onward transmission to INCB. - 7. It has been observed from certain cases which have come to us that the State Drug Controllers have extended the validity of 2009 quota upto 31st March 2010. This is to inform you that the quantity procured and consumed in Calendar year 2009 only may be indicated for purpose of consumption. The quantity of quota extended beyond 31st December, 2009 will be counted as

allocation for 2010 and if more allocation is required, necessary application for grant of quota may be made to this office at the following address:
