## Terms and Conditions:

- (A) Bidding firms shall submit the following documents along with their bids:-
  - Copy of Pan Card
  - Copy of GST registration
  - Cancelled cheque
  - Copy of the Drug License for wholesale of Narcotics & Pshychotropic medicines
- (B) Auction of the Buprenorphine tablets will be held in accordance with the guidelines issued by the Drugs Controller General of India vide F.No. 4-01/2018-DC (Misc. 42) dated 28.03.19 the Buprenorphine 2mg/0.4 Mg sublingual tablet and FDC of

Buprenorphine + Naloxone (2mg + 0.5 Mg & 0.4 mg+ 0.1 Mg)sublingual tablet shall be supplied only to Psychiatric Clinics & hospitals, Govt approved De-addiction Cenrtres and Govt De-addiction centers only. Therefore, only Psychiatric clinics & hospitals and De-addiction centres will be allowed to bid.

(C) Auction of pills & capsules containing medicinal opium will be held in accordance

with rules & regulations made by the concerned State Excise Department.

(D) The participating firm shall submit a undertaking that his firm is neither convicted or facing any cases under NDPS Act or Drugs & Cosmetics Act & rules.

(E) The successful firm shall deposit the bidding amount within one week after the auction

for receiving the Narcotics & Psychotropic Medicines.

- (F) Selected bidder firm will have to take over the Narcotics & Psychotropic Medicines within 3 days after the deposition of the bidding value.
- (G) After receiving of Narcotics & Psychotropic medicines all responsibility of sale, store & possession will be of the selected firm
- (H) If any firm wants to withdraw its name after the Auction procedure, then its Earnest money will be forfeited.
- (I) Earnest money:
  - (a) Earnest money amounting to Rs.1,00,000/-(One lakh only ) in the form of a Demand Draft/Pay Order drawn in favor of the Drawing and Disbursing Officer of Deputy Narcotics Commissioner, payable at Neemuch has to be submitted along with the bid failing which, the bid shall be rejected.
  - (b) The Bidder firm found without Earnest Money Deposit will be summarily rejected.
